MINUTES OF CITY COUNCIL CITY OF SARGENT, NEBRASKA Regular Session Sargent Community Center February 13, 2012

The Mayor and Council of the City of Sargent, Nebraska, met in Regular Session at the Sargent Community Center on the 13th day of February, 2012, at 7:00 p.m. Notice of the meeting was posted at the City Office, U. S. Post Office, Sargent Corner Market and First National Bank on Tuesday, January 31, 2012. The following were present: Mayor Mick Kozeal; Council Members: Jan Oeltjen, Ron Jepsen, Tim Leibert, and Micky Schneider. Also present: City Administrator/Utility Superintendent Mike Criss, Officer J D Keefe, and City Clerk/Treasurer Gwenda Horky.

Mayor Kozeal publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted on the east wall of the meeting room in the Sargent Community Center. Mayor Kozeal called the meeting to order at 7:08 p.m.

Council Member Jepsen moved to approve the consent agenda. Council Member Leibert seconded. Voting yea: Oeltjen, Jepsen, Schneider and Leibert. Voting nay: None. Motion carried

Citizen Comments: Mark Koch expressed his concern of not being able to get a building permit from the City Council.

Officer Keefe will talk to the court about the time limit that Jerry White has on cleaning up his properties.

Mark Koch informed the City Council that he thought he had done a good job of cleaning up and wondered what more the City Council wanted cleaned up.

Council Member Jepsen nominated Jan Oeltjen for President of the City Council. Council Member Schneider seconded. Voting yea: Jepsen, Schneider, and Leibert. Abstaining: Oeltjen. Voting nay: None. Motion carried.

Council Member Schneider nominated Mick Kozeal as the representative to the Loup Central Landfill. Council Member Oeltjen seconded. Voting yea: Jepsen, Schneider, Oeltjen, and Leibert. Voting nay: None. Motion Carried.

Council Member Jepsen introduced Ordinance # 471

AN ORDINANCE AUTHORIZING AND DIRECTING EXECUTION OF THE EAST SIDE BULK POWER SUPPLY AGREEMENT AND AMENDMENT NO. 1 THERETO, BY THE CITY OF SARGENT, NEBRASKA, WITH THE MUNICIPAL ENERGY AGENCY OF NEBRASKA; TO REAFFIRM TERMS OF THE ELECTRICAL RESOURCES POOLING AGREEMENT AND THE CITY'S STATUS AS A BULK

POWER PARTICIPANT; TO PRESCRIBE THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT. TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM

Council Member Leibert moved to condemn the house and garage at 204 East Della, Sargent, NE. Council Member Schneider seconded. Voting yea: Oeltjen, Leibert, Schneider and Jepsen. Voting nay: None. Motion carried.

Council Member Leibert moved to condemn the building on 403 West Main Street, Legal Description: the east 12.5 feet of Lot 6, Block 7 Original Town of Sargent, and the west 12.5 feet of lot 6, Block 7, Original Town of Sargent.

Discussion was held on replacing the current handheld electric and water meter readers.

Discussion was held about adverting for the Pool Manager for the summer.

Discussion was held on the Short-term Disability Policy that the City has on employees.

Supervisor reports were given.
