The Mayor and Council of the City of Sargent, Nebraska, met in Regular Session at the Sargent Community Center on the 14th day of March, 2011, at 7:00 p.m. Notice of the meeting was posted at the City Office, U. S. Post Office, Sargent Corner Market and First National Bank on Monday, February 28, 2011. Also present were, JD Keefe, City Administrator/Utility Superintendent, Mike Criss, and City Clerk/Treasurer, Gwenda Horky.

Mayor Kozeal publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted on the east wall of the meeting room in the Sargent Community Center. Mayor Kozeal called the meeting to order at 7:02 p.m.

Council Member Leibert moved to approve the consent agenda. Council Member Oeltjen seconded. Voting yea: Oeltjen, Jepsen, Leibert, and Schneider. Voting nay: None. Motion carried

The Mayor announced that the introduction of an ordinance was now in order.

Council Member Oeltjen introduced Ordinance No. 460

Council Member Leibert moved that Ordinance No. 460 be passed, approved and published as provided by law. Council Member Oeltjen seconded. Voting yea: Oeltjen, Leibert, Jepsen, and Schneider. Mike Kozeal was present to talk to the Council about the ball field. Summer Rec is planning on updating the pitcher's mound, adding more Diamond Pro to the in-field, extending the fence, and a 4-wheeler to drag the field.
