# Regular Session Sargent Community Center February 8, 2010

The Mayor and Council of the City of Sargent, Nebraska, met in Regular Session at the Sargent Community Center on the 8<sup>th</sup> day of February, 2010, at 7:01 p.m. Notice of the meeting was posted at the City Office, U. Discussion was held about the electricity rates. At the present time Sargent will go up the scheduled 7.2%.

Supervisor reports: Officer Keefe reported that he has never loss any evidence that has been brought in to the city office. A complaint has been made about snow not being removed from the sidewalks in town. Ms. Horky reported that Sonnia Bottorf has started working in the office. Mr. Criss reported that the grader needs major repair work done. Mr. Kozeal reported that the Loup Valley Land Fill will be looking for a new manager next year, and how helpful the Burwell transfer station has been.
