MINUTES OF CITY COUNCIL CITY OF SARGENT, NEBRASKA Regular Session Sargent Community Center March 8, 2010

The Mayor and Council of the City of Sargent, Nebraska, met in Regular Session at the Sargent Community Center on the 8th day of March, 2010, at 7:00 p.m. Notice of the meeting was posted at the City Office, U. S. Post Office, Sargent Corner Market and First National Bank on Saturday, February 27, 2010. The following were present: Mayor Mick Kozeal; Council Members: Jan Oeltjen, Tim Leibert, Bob Nitchie and Micky Schneider. Also present were City Administrator/Utility Superintendent, Mike Criss, Police Officer J D Keefe, and City Clerk/Treasurer, Gwenda Horky.

Mayor Kozeal publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted on the east wall of the meeting room in the Sargent Community Center. Mayor Kozeal called the meeting to order at 7:03 p.m.

Council Member Nitchie moved to approve the consent agenda. Council Member Leibert seconded. Voting yea: Oeltjen, Nitchie, Leibert and Schneider. Voting nay: None. Motion carried

No citizens' comments were made.

Condemned Properties were discussed.

Changes have been made to the Employee Handbook. There are a few more changes that need to be made.

Corrinne Pedersen from NMPP Energy called the clerk and would like to make an appointment to continue the work that was started in 2006. A Strategic Plan was started; the clerk will call Ms. Pedersen and set up an appointment,

Council Member Leibert moved to approve Supplemental Agreement between the State and the city of Sargent and appoint Laurie Hansen form Central Nebraska Economic Development District as the Responsible Charge. Council Member Oeltjen seconded. Voting yea: Oeltjen, Leibert, Nitchie, Schneider.

Resolution #2010-01-03 declares that the City of Sargent and the State of Nebraska had previously entered into a n agreement for a Safe Routes Project YL0906. The construction of the project will be under Project No SRTS-21(24) and the Responsible Charge (RC) for the project will be Laurie Hansen. Council Member Nitchie seconded. Resolution #2010-02-03 was introduced by Council Member Oeltjen. Resolution # 2010-02-03 declares the City of Sargent to adopt a policy opposing discrimination in the acquisition, ownership, possession or enjoyment of housing; to assist aggrieved person in filing complaints by providing certain information. Council Member Leibert seconded. Voting yea: Oeltjen, Nitchie, Leibert and Schneider. Voting nay: None. Resolution # 2010-02-03 passed and approved.

Resolution # 2010-03-03 was introduced by Council Member Oeltjen. Resolution # 2010-03-03 declares the city of Sargent to adopt a policy for the grievance and complain procedure for §504 of the Rehabilitation Act of 1973. Council Member Leibert seconded. Voting yea: Oeltjen, Nitchie, Leibert, and Schneider. Voting nay: None. Resolution #3010-03-03 passed and approved.

Discussion was held on the building permit for Louis Ropers Jr. The council will make a decision after the lot has been surveyed.

Discussion was held on the about Economic Development. The city's 1% sales tax that is designated to the streets will end January 1, 2018. Central Nebraska Economic Development District is another resource that the City may use.

Council Member Oeltjen moved that the City of Sargent allow Martin Riddle to pasture the sewer pond at no cost. Council Member Schneider. Voting yea: Oeltjen, Nitchie, Leibert, and Schneider. Voting nay: None. Motion carried.

Discussion was held on Utility rates. At the present time the City will stay with the scheduled light increase. An increase in sewer and water will be discussed at a later date.

Supervisor reports were given; Mr. Criss talked about utility rates, and other utility issues Ms. Horky and Ms. Bottorf have been to a funding workshop. Mr. Keefe will be ordering several new STOP signs.

Mayor Kozeal announced that the Council was going into closed session for the protection of the public interest to discuss economic development loans.
